**3. PROFILE OF SKILLS AND COMPETENCES**

- Vocational-specific communication in the instruction language and in two foreign languages;
- Independent creation of written texts in an accurate, grammatically correct and practice-oriented manner;
- Knowledge of natural sciences (chemistry, physics, biology, ecology), applied mathematics, history and political education;
- Knowledge of art history, fashion history and trend research;
- Knowledge of the legal provisions relevant to private and professional life as well as the ways of enforcing the law;
- Knowledge about economic systems and economic areas, economic structures and processes;
- Application of basic entrepreneurial knowledge, e.g. investment and financing decisions, business start-up and management, human resources management and development;
- Recognition of business management contexts, problem-solving skills;
- Performance of operational accounting tasks, solution using standard programs and evaluation of the results; cash-based accounting, double-entry bookkeeping, cost accounting in small and medium-sized enterprises, personnel accounting, annual financial statements of individual enterprises and partnerships;
- Application of basic knowledge in the area of information technology, practice-oriented use of standard software (text processing, spreadsheets, presentation and image processing, databases);
- Planning, performing and follow-up of speeches and presentations;
- Performing tasks in service management, sales management, customer management; advisory and sales talks;
- Planning, management, implementation and completion of projects using subject-specific software;
- Performing quality management tasks;
- Performing merchandise management tasks;
- Application of knowledge and skills in the field of analysis, cleaning and care of scalp and hair, preparation of treatment plans;
- Implementation of different cutting and curling techniques as well as post-treatments, shaving and shaping of beards; selection of suitable reshaping products;
- Hairstyle design using various styling techniques (putting in rollers, waving, using papillotes, using thermal appliances and finishing products); pinned-up hairstyles incl. incorporation of hairpieces and hair accessories, hair extensions, colour change of hair using various application techniques;
- Colour, type and style consultation, taking into account the shape of the face and body;
- Production of wigs and hairpieces from hair and non-hair materials;
- Development of mask designs as well as planning, design and creative design of masks; fabrication of rigid and flexible masks, body parts and bald heads in different processes and forms (e.g. hollow mould process);
- Production of special effects such as skin changes, action injuries, deformities, tattoos etc. (made up, moulded onto the skin or glued on from prefabricated parts);
- Implementation of a holistic mask design on the model in various projects with the integration of all mask-related fabrications;
- Make-up design using different techniques for various occasions;
- Implementation of eyelash extensions and thickening, creating eyelash perms;
- Treatment of hands and fingernails; diagnosis, extension and strengthening;
- Application of knowledge from the field of fashion and beauty photography, incorporating contemporary tools.

**Professional fields:**

<b>Additional information</b>  <b>Entry requirements:</b> successful completion of school year 8, if necessary entry examination; <b>Duration of education:</b> 5 years; <b>Duration of compulsory work placement:</b> 3-month compulsory work placement between the 3rd and 4th year; <b>Education goals:</b> Intensive five-year vocational training in general education, occupation-related practice, occupation-related theory and business-oriented subjects. Teaching of knowledge and skills qualifying graduates to directly exercise a high-level profession in the business sphere, especially in the areas of hairstyling and cosmetology, as well as to take up academic studies.
