- The use of basic knowledge in companies with regard to financing and investment, company founding, marketing, e-commerce;
- Recognizing company and business relationships, problem-solving competence;
- Knowledge about the performance areas of the company in the fashion industry and about company activities and tasks in the clothing industry and trade;
- Knowing the means of legal recourse significant for private and working life, providing and evaluating legal information;
- Perception of business accounting tasks and solutions with the help of standard software, e.g. cash accounting, double book keeping, annual accounts of one-man businesses, cost accounting including branch-specific calculations, personnel accounting;
- Applying basic knowledge in the area of information technology, practice-oriented use of standard software in the areas of text processing, table calculation, presentation as well as graphics and image processing;
- Gathering information, data management, data protection and security;
- Applying knowledge of textile fibers, threads and surfaces, care and textile labeling, characteristics, care and functionality of textiles, textile refinement, consideration of ecological aspects;
- Producing manual designs and technical drawings as well as CAD-supported designs, fashion and technical drawings, creation of a collection;
- Manual and digital pattern construction, creation and development of models;
- Planning, controlling and performing including presentation;
- Application of knowledge in the areas of work system creation, work security and work protection, process creation, quality management;
- Manufacturing work pieces with the technical-specific and security-conscious use of the necessary work and company means, recognizing security guidelines, applying technical-specific manufacturing techniques and work methods; creating the necessary production papers;
- Applying skills in the area of decoration and presentation of goods; market-oriented creation of eye-catchers, product groups, showrooms and show windows;
- Development of relevant advertising media taking with consideration to advertising-psychological aspects;
- Leading sales and counselling talks; negotiation techniques;
- Knowledge in the areas of distribution channels in fashion trade, visual merchandising and logistics.

**Additional information**

**Entry requirements:** successful completion of school year 8, if necessary entry examination;

**Duration of education:** 3 years;

**Duration of compulsory work placement:** work placement 4 weeks in all during holidays;

**Education goals:** Intensive three-year vocational education in general education, vocational-practical, vocational-theoretical and economic subjects. Imparting knowledge and skills that qualify the degree holders to exercise directly in the professional economic area, particularly in the fashion and textile industry. Important goals are professional and social competence, personality development, ability to be vocationally mobile and flexible, criticism, self responsibility, social engagement, creativity, ability to work in a team, ability to communicate in the instruction language and in English, readiness to permanent further education.
