Duration of education: 5 years;

**Education goals:** Intensive five-year vocational education in general educational, technical theoretical, technical practical and business subjects. Imparting knowledge and skills that qualify students for advanced professions in the middle management level, particularly in organization and administration in the social and health area, in social-profit-organizations and in the economy, as well as entry to a university. Important goals are professional and social competence, personality development, ability to be vocationally mobile and flexible, criticism, self responsibility, social engagement, creativity, ability to work in a team, ability to communicate in the instruction language and foreign languages, readiness to permanent further education.
